# SEXUAL MISCONDUCT CLIMATE ASSESSMENT SUMMARY



# OVERVIEW

During the summer of 2022, all students were invited to participate in a survey regarding the environment for learning, living and working at Ithaca College. The results serve to help our community identify opportunities for growth and improvement.

The survey results represented in this summary pertain to Unwanted Sexual Behavior, which was divided for the purposes of this survey into four categories of behavior: *Stalking* (following in person or on social media, texting, phone calls, etc.), *Relationship Violence* (ridiculing, controlling, abuse), *Unwanted Sexual Contact* (non-consensual sexual touching, assault, penetration) or *Unwanted Sexual Interactions* (non-contact: sexual advances, cat-calling, harassment).

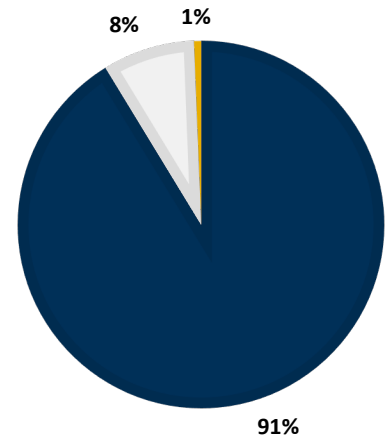

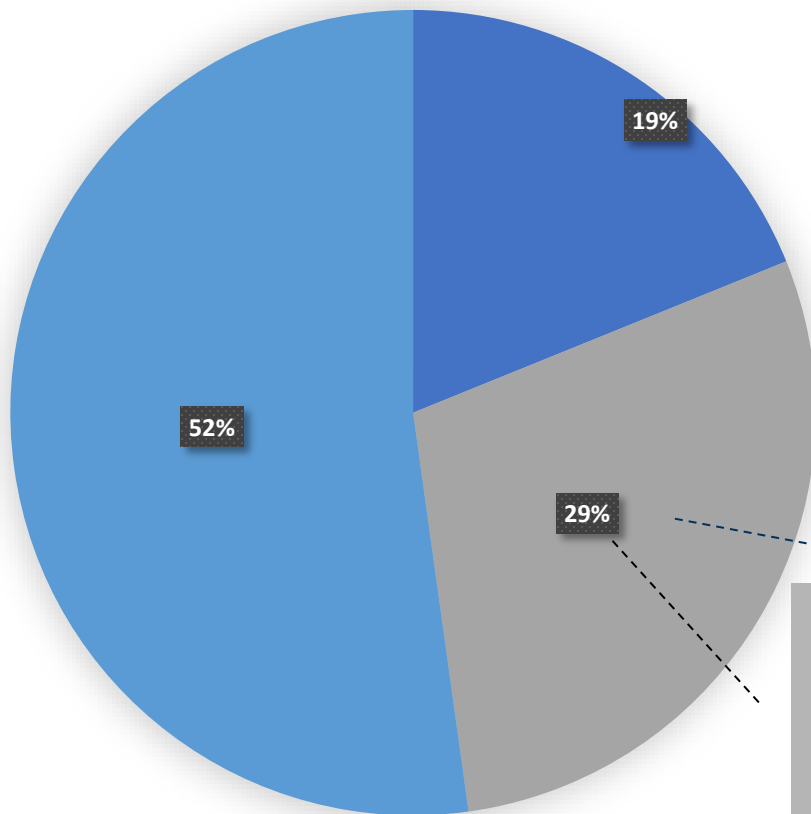

### Students Experiences of Unwanted Sexual Behavior



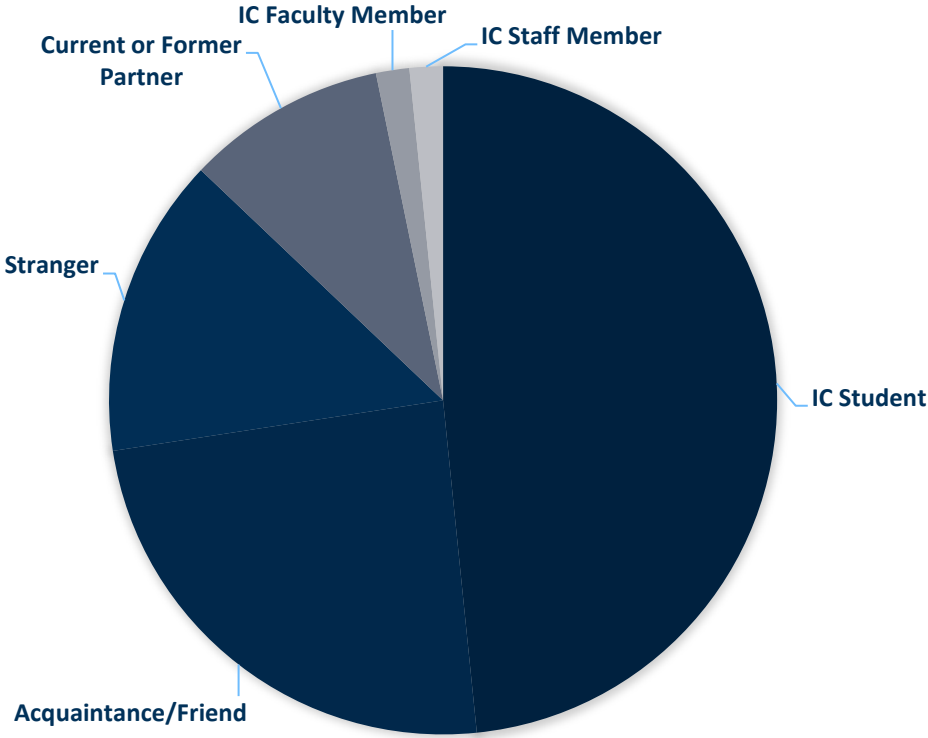
- Did not indicate whether they experienced unwanted sexual behavior

**BREAKDOWN BY CATEGORY:** For the Respondents who experienced Unwanted Sexual Behavior:

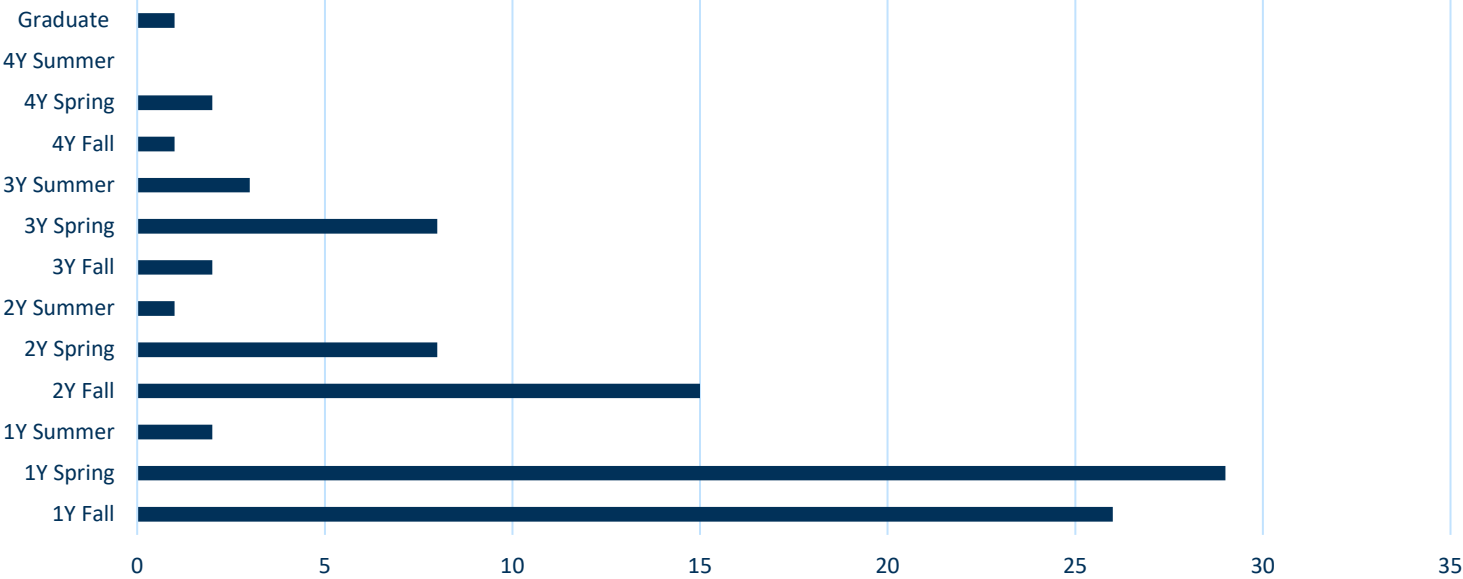
- 7% said it included *Relationship Violence*
- 26% said it included *Stalking*
- 65% said it included (non-physical) *Unwanted Sexual Interaction*
- 47% said it included *Unwanted Sexual Contact*



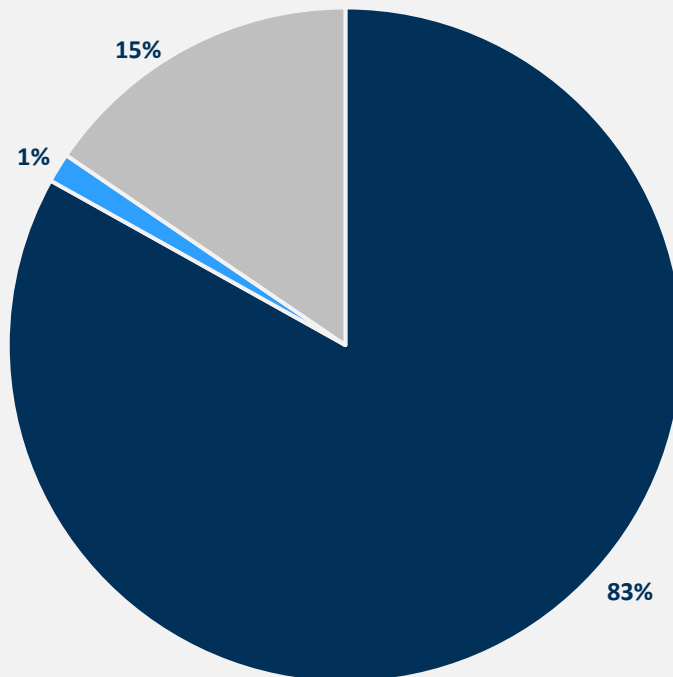
# Survey Respondents' Classifications of Offenders



# When the Unwanted Sexual Behavior Occurred



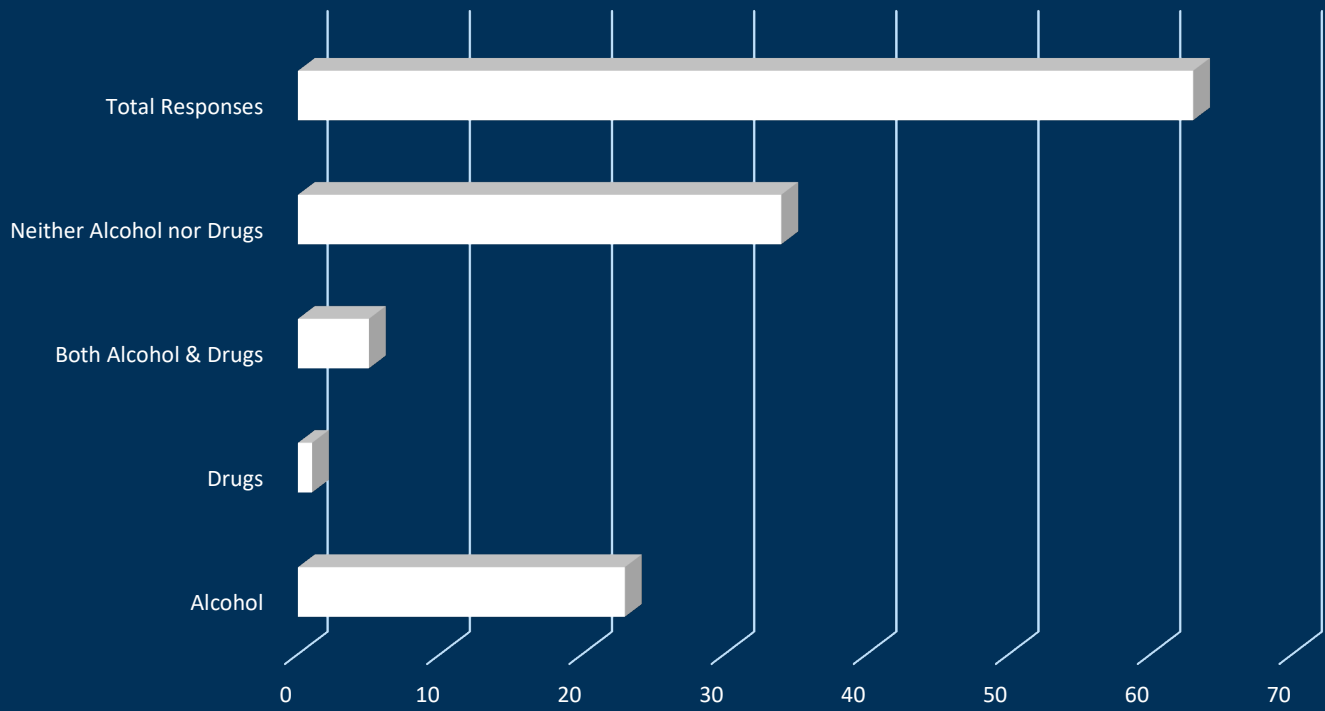
## Incidents Reported to College Officials



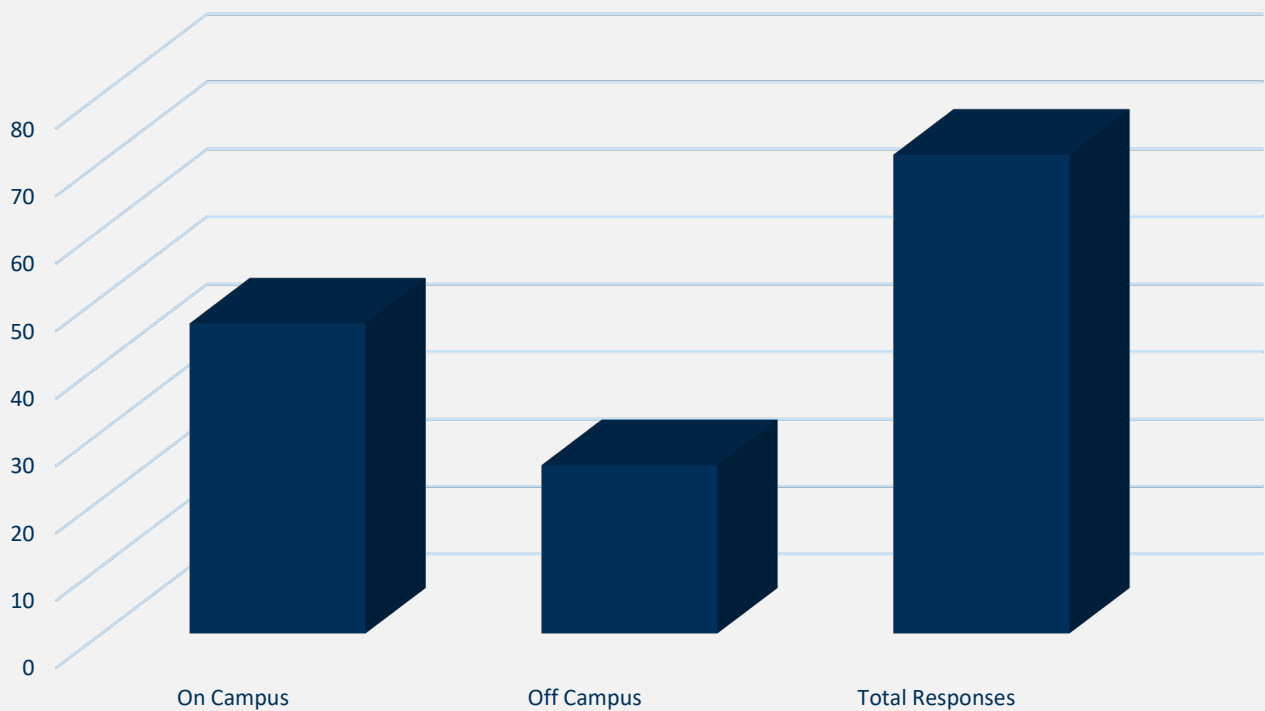
- Incidents Not Reported

Forty-six (46) survey responders indicated *seventy-one* (71) instances of unwanted sexual behavior. Of those 71 experiences, the survey indicates that *twelve* (12) led to reports made to Ithaca College officials. Of the 12 reports to College Officials, survey responders indicated that *one* (1) was handled appropriately and *eleven* (11) were not handled appropriately.
